This Amendment (the "Amendment") modifies and amends the legal agreement between GiveCampus, Inc. ("GiveCampus") and the entity you represent ("you" and "your") (the "Agreement"). This Amendment is effective upon the date you first enable, access, or use Chariot Giving Inc.'s ("Chariot") Donor Advised Fund donation facilitation services ("DAFpay") in connection with your use of GiveCampus and continues until you or GiveCampus terminates it. Capitalized terms used in this Amendment that are not defined herein are defined in GiveCampus's online terms and conditions available at <a href="https://go.givecampus.com/legal">https://go.givecampus.com/legal</a>. Except as expressly amended herein, all other terms and conditions of the Agreement remain unchanged and in full force and effect.

By enabling, accessing, or using DAFpay, you hereby acknowledge and agree that:

- 1. Chariot is a Payment Processor, Chariot's services are a Third Party Service, and your use of Chariot's services (including DAFpay) are subject to Chariot's terms of service which are a Third Party Contract.
- Your contractual rights and obligations with regard to Chariot's services (including DAFpay) shall be set forth solely in Chariot's Third Party Contract. GiveCampus shall not be responsible for any action or inaction of Chariot or any breach or other liability related to Chariot's services or arising under Chariot's Third Party Contract.
- 3. Donations initiated or processed through Chariot's services ("DAF Grants") cannot be cancelled, reversed, charged back, or refunded.
- 4. DAF Grants are subject to the same payment terms and fees as other Donations under the Agreement.
- 5. Chariot, and not GiveCampus, is responsible for facilitating the communication of information about Donors and DAF Grants to the operators of each applicable Donor's designated donor advised fund(s) (each a "DAF Sponsor").
- 6. GiveCampus shall not be responsible for any acts or omissions of DAF Sponsors, including but not limited to a DAF Sponsor's decision to disburse funds to you (or not) and a DAF Sponsor's disbursement of funds or failure to disburse funds to you.
- 7. GiveCampus's interoperability with Chariot's services and ability to provide you with access to Chariot's services relies on Chariot's cooperation and ongoing maintenance of and provision of access to GiveCampus to Chariot's application programming interface(s) (API) (the "Required Support"). Chariot may discontinue its cooperation and/or suspend the Required Support at any time and GiveCampus is not responsible or liable for any disruptions in service caused by any such discontinuation or suspension.
- 8. In the event that Chariot changes or increases the fees it charges GiveCampus related to Chariot's services (including but not limited to API fees, support fees, and/or

processing fees), then GiveCampus shall have the right to change or increase the fees it charges you for your access to and use of Chariot's services in connection with your use of GiveCampus; provided that, GiveCampus shall provide you with no less than ninety (90) days advance notice of any such change or increase and you shall have the option to disable and discontinue your use of Chariot's services in connection with your use of GiveCampus before owing any such changed or increased amounts.
